

Exchange Visitor Pre-Arrival Guide - Transfers -

Cultural Goals and Components of the Program:

There are specific objectives of an **Exchange Visitor Program** (EVP). In addition to facilitating an opportunity to visit the U.S. for a program of **research**, **teaching**, **or collaboration** in an academic setting, an equally important aspect of the program is to promote **cultural exchange** and **foreign diplomacy**, and through research, teaching, and collaboration that cultural exchange and foreign diplomacy are accomplished.

The Exchange Visitor Program promotes the sharing of knowledge and skills among foreign and American scholars. It does so by providing foreign scholars the opportunity to exchange ideas with their American colleagues, participate in educational and professional programs, confer on common problems and projects, and promote professional relationships. This may be accomplished through lecturing, observing, consulting, and participating in seminars, workshops, conferences, study, professional meetings, or similar types of educational and professional activities.

Maintaining Your Legal Status

As a Transfer, remember to continue to follow the guidance of your <u>current</u> J-1 Exchange Visitor Program, as they are responsible for your legal visa status until your SEVIS transfer is completed. Please read the information on page #4 (of this document) under "Traveling Outside of the U.S. While Your SEVIS Transfer is Pending", as traveling during a pending transfer is very risky. A delay in travel to the U.S., or using the incorrect DS-2019 to enter the U.S., or even an application for a **new visa** while outside of the U.S., may cause delays and prevent you from successfully entering the U.S. to continue your Exchange Visitor Program. A **new DS-2019** will be provided on or after the SEVIS transfer effective date.

Review the online pre-arrival orientation

The **Homebase on-line pre-arrive guide** provides additional information on the Exchange Visitor Program, visa regulations, and cultural aspects of the Salt Lake City and Utah community. To **create a profile**, please click the **Homebase link** and follow these steps:

- Select your institution: University of Utah
- Input the program number: 154-11-75
- Type in your name, e-mail address, date of birth, gender, and country of residence
- Create a password (Password must be at least 8 characters long and contain at least 1 lowercase letter, 1 uppercase letter, 1 numeric and 1 special character, such as the following: !@#\$%^&)
- Click "Create Account". You will then be redirected to the University of Utah Pre-Arrival and Orientation guide



Providing Proof of Health Insurance:

Exchange Visitors and their dependents must maintain health insurance during their exchange visitor program. Please review the document included in in your pre-arrival packet titled **Health Insurance**Requirements or click here for the health insurance page on our website for more information, as well as item (f), page 2 of your DS-2019. Please be aware that an EV and dependent spouse or minor child may be subject to the requirements of the Affordable Care Act.

Some EVs may be eligible for the University's health plan. Please check with the department hosting your visit to find out if you are eligible. If you are eligible for the University plan, details can be retrieved here. **Note:** Even if this is offered to you, you still need to proactively take action and sign up of for the University plan.

The University of Utah does not endorse private insurance plans, but if you are <u>not</u> eligible for the University's health plan and need to purchase private insurance, the following companies offer plans compliant with J visa requirements. Please conduct your own research, and consider an option that is more comprehensive than the minimum requirements based on the health care needs of you and your family. We've provided a list of a companies that write insurance that meets the Department of State's minimum requirements:

Proof of insurance, such as a summary of benefits, declaration page, letter from your insurance or government provider identifying your coverage is necessary to validate your SEVIS record. Click here for additional resources and an <u>overview of the healthcare system in the US</u> and how it relates to EVs. If you are unable to provide proof of insurance to match the research begin date at the University of Utah, we will not be able to validate your SEVIS record. Failure to provide proof of health insurance that meets the minimum requirements of the US Department of State will result in TERMINATION of your visa status.

Housing options (on and off campus):

While the University of Utah cannot guarantee on-campus housing for exchange visitors, we have provided the following websites for housing options on campus, and around the Salt Lake metro area. Your host department may also have additional resources for housing options.

Reporting Your On-campus Arrival through UAtlas:

Upon transfer and arrival campus for a new EV program, you must report your arrival to International Student and Scholar Services, which should be done within a few days of transfer. Reporting is necessary to validate your SEVIS immigration record, giving you an <u>ACTIVE</u> immigration status. Please be aware that if you do not report your arrival within 30 days of the program begin date as listed on your DS-2019, your immigration status will change to <u>NO SHOW</u>, which is <u>not</u> a legal status for any type of employment based or education based program in the USA. Please refer to the instructions included in the pre-arrival packet on how to report your arrival using <u>UAtlas</u>.

Please be prepared to submit the following as part of the reporting process through UAtlas:

- PASSPORT
- J-1 VISA (with "stamp" from Customs and Border Protection)
- **DS-2019** with US Consular signature
- I-94 document. To retrieve this document, which identifies that you entered the U.S. in J visa status, go to https://i94.cbp.dhs.gov/I94/#/home
- Proof of health insurance coverage. This should include your policy number and amount of coverage.
- Current **physical residential address** in the United States and current contact information (**e-mail address and US phone number**)

Attending Orientation:

Please participate in **Orientation is required**, even for transfers, which occurs twice per month via Zoom. You will have an opportunity to sign up for the orientation <u>after</u> you report your arrival to campus and complete the check-in procedures. The following is a sample of the information covered during orientation:

- Life, customs, and cultural activities in the US
- Community resources, such as transportation and libraries, and healthcare options
- Description of the Exchange Visitor Program and position disclosure information
- Information on visa regulations, sponsor (University of Utah) rules, and how to maintain your legal status in the US
- Contact information: the name and address of the J-1 advisors (RO and ARO) at the university, as well as the Office of Designation (US Department of State)
- Information about applying for a driver's license, social security card, and bank account
- The Wilberforce Pamphlet regarding the rights and protections for temporary workers
- The Exchange Visitor Program Welcome Brochure

Traveling Outside of the USA While Your SEVIS Transfer is Pending:

If you plan to depart the United States with an intent to re-enter <u>after</u> your "transfer" effective date, please be prepared to provide the following documents to U.S. Customs and Border Protection (CBP) at a U.S. port of entry (air, land, and sea), upon arrival:

^{**}The new "transfer" DS-2019 will be provided only after the SEVIS transfer occurs and only after the checkin process is complete.



- PASSPORT
- J-1 non-immigrant VISA STAMP
- Original form DS-2019 from the University of Utah
 * If necessary, you will have to pay the cost for the University to express mail the DS-2019 to you.
- The **INVITATION** or **OFFER LETTER** from the University

The **transfer effective date**, which is the date your SEVIS record is available to the University of Utah, will be your new <u>program begin date</u> at the University. The University of Utah must validate your SEVIS immigration record within **30 days** of this date, and we can only validate your record <u>after</u> the transfer effective date and only and after you have reported to ISSS through UAtlas.

If we are unable to validate your SEVIS record, your visa status will become "NO SHOW", which is not a legal status for employment based or educational based programs in the USA. Understand that traveling abroad during a pending SEVIS transfer is very risky, as there is no guarantee that you will be allowed to re-enter the USA after a departure while a SEVIS transfer is pending.

Final Reminders:

Please remember that it is **your responsibility** to be knowledgeable of the **rules and regulations** of your visa type. This is important in order to understand the benefits and protections you are given as visitors to the US. Much of this information is covered on the **Homebase online pre-arrival guide** (see how to access this on page 1 of this document), and will be covered at the Exchange Visitor orientation after arrival. We will also be available during your stay for one-on-one advising sessions for any visa related questions. Another helpful resource is the Department of State's Exchange Visitor page.
