The purpose of the Exchange Visitor (EV) Program is to provide visitors to the U.S. with an opportunity to participate in educational and cultural programs and to share their experiences upon their return home, as well as to encourage Americans to participate in educational and cultural programs in their country.



## **DID YOU KNOW...**

If you will be out of the country for **more than 30 days** and you intend to return to continue your Exchange Visitor program, you must receive authorization for a **Temporary Out of Country Absence** or your SEVIS immigration record will become inactive and your J-1 program will complete.

To be eligible for a Temporary Absence, you must:

- Continue to pursue your original program goals and objectives. Your research or collaboration with the University of Utah must be ongoing and continue to be a benefit to the University.
- Maintain the required health insurance for yourself and your dependents even when abroad.
- Remain under the supervision of your supervisor or PI at the University of Utah.

### **DID YOU ALSO KNOW...**

Your passport is both an official form of identification and a travel document, issued by your



government, and needed for many important activities, such as travel abroad, opening a bank account, and getting a driver's license.

U.S. Department of State regulations disclose that a passport must be valid at the time of admission (entry) to the U.S. and must also be valid for a minimum of six months **beyond** the expiration of your initial period of stay, unless your country is a member of the six-month club. If a member of the <u>six-month club</u>, your passport must only be valid for your period of stay, not six months beyond this date.

If you passport expires, or is lost or stolen, please let ISSS know, as we are happy to answer any questions that you may have. Remember that an expired passport **does not** put you "out of status" with your visa, but is required to valid at all times, and can prevent you from certain benefits, such as an extension of your stay. In most cases, this can be done through your country's U.S. Embassy or Consulate.

#### **Health Insurance Update**



We are approaching the next bi-annual mandatory health insurance update. As a reminder, proof of health insurance must be updated at all times in order to maintain legal J-1 visa status. This can be done through the Health Insurance Update Request E-form through <u>UAtlas</u>.

## PLEASE REMEMBER TO ALWAYS...

- Update ISSS of any change in your physical address, phone number, and e-mail address within <u>10</u> calendar days of the change through <u>UAtlas</u>.
- Request a travel signature on your DS-2019 if you plan to depart the U.S. and return to continue your exchange program. When you submit your DS-2019 for a travel signature, we will provide a travel survey for you to complete. The travel survey lists information helpful to know to successfully re-enter the U.S.
- Maintain health insurance that <u>meets the requirements</u> of the Exchange Visitor Program for the entire duration of your stay as indicated by the begin date and end date listed on your DS-2019.
